As the intention of the applicable Civil Service Rule is to give City of New Haven residents preference points on open competitive examinations, the Personnel Director is authorized to require proof that an applicant meet all the conditions of the domiciled status set forth above.

For the purpose of this Application for Preference Points, "<u>**POMICILED**</u>" is defined as "that place where an individual has a true, fixed, and permanent home and principal establishment, and to which whenever the person is absent, they have the intention of returning. A person may have only one domicile principal home, whereas they can have several residences."
