4. Photocopy Firefighters 2 Certificate
5. Copy of RI EMT-B or NREMT-B License
6. Provide past training records from your previous eligible fire service experience

All documents must be legible and will be retained by the Rhode Island Airport Corporation.

All requested documents must be submitted to be considered for the position.
