B. ESSENTIAL FUNCTIONS OF JOB:

In addition to duties imposed by the Fire Lieutenant or any other superior officer from time to time and by applicable law, the essential job functions and responsibilities of the Firefighter/EMT include:

Performing firefighting duties; using fire extinguishers, bars, hooks, attack lines, and other equipment; ventilate burning buildings, remove people from danger; applies salvage covers and removes debris.

Connect hose lines to hydrants or fire trucks, operate pump high pressure hoses and position ladders as necessary for fire department incidents.

Drives and operates all types of firefighting vehicles and equipment.

Participates in Emergency Medical Services (EMS) and rescue work.

Checks and cleans equipment after returning from a fire department incident.

Checks and cleans firefighting equipment daily to ensure all equipment and apparatus are in good working condition.

Participate in fire prevention programs.

Prepare written reports as required.

Assists in keeping fire stations in clean and orderly condition.
